ORDER:

The Government of Andhra Pradesh have framed policy and guidelines on recruitment of persons on Outsourcing/Contract basis and also on engaging the Agencies for outsourcing support services along with emoluments etc. During the implementation of the policy, several complaints have been received against engaging the services of Outsourcing Agencies including these Agencies not passing the full remuneration to the outsourced employees in many instances.

2. Against this backdrop, Government felt it necessary to incorporate a dedicated Corporation that will directly outsource manpower to various Departments/Organisations in the State as per their requirements. It will do away with the involvement of middlemen and other agencies, and create a transparent system for providing outsourced employees and services to the Departments/Organisations across the State, thereby extending maximum benefits to the outsourced employees. The Corporation will also hire agencies to provide services such as consultancy, security and facility management and other services such as housekeeping, vehicles, etc. The Corporation will act as one stop shop to the Departments/Organisations for centralized hiring of outsourced employees and services in the State.

3. Keeping in view of the above, Government hereby accord approval for incorporating, "Andhra Pradesh Corporation for Outsourced Services", under Section 8 of the Companies Act, 2013, as a non-profit organization, which will be under the administrative control of General Administration Department.

4. The G.A. (SU.I) Department shall take necessary further action for formation of the Corporation immediately.
